1. A deposit of £10.00 per adult and £5.00 per child (non-refundable and non-transferable) is required at the time of booking. provisional bookings will only be held for seven days.
2. The total balance outstanding is required by 31.10.2023. If the balance is not received by this date, the booking will automatically be cancelled.
3. Cancellation policy - deposits, part payments and full payments are non- refundable and non-transferable under any circumstance.
4. If your booking is made within 8 weeks of arrival, full prepayment will be required.
5. One cheque or payment only per group is permitted for party bookings (individuals must go through the party organiser and cannot make an individual payment). Please note: the following on the back of the cheque: name and address of the organiser, date of the function, lead name on the booking. cheques should be payable to Bryn meadows golf, hotel, spa.
6. Number of guests may be increased (subject to availability) however any cancelled places will not receive a refund.
7. Any amendments to the final pre-paid number of guests should be advised in writing to the hotel a minimum of 7 working days prior to your event.
8. Dietary requirements should be advised in writing to the hotel, a minimum of 7 working days prior to your event. Menu items are subject to availability and may be substituted at the hotel's discretion without notice.
9. If a specific pre-ordered wine is unavailable, it will be replaced with an alternative of the same standard.
10. Prices quoted are inclusive of VAT at 20% at the time of booking and may be subject to alteration should the vat rate change.
11. Beverages of any kind are not permitted to be brought into Bryn Meadows golf, hotel, spa by the event guests or clients. Beverages will be held by our security department and returned to our guests after the event. Guests may be removed from the premises if this occurs multiple times throughout the event.
12. You will be liable for the cost of repairs carried out as a result of any damage caused to any part of Bryn meadows golf, hotel & spa premises or equipment thereon, by negligence, wilful act or default of any person invited by you or on your behalf to the hotel. The hotel management will not accept liability in respect of any loss or damage to articles brought on to the premises.
13. In the event of a party or event having to be cancelled by Bryn Meadows golf, hotel, spa an alternative date will be offered, or a full refund given without liability to the hotel.
14. Bryn Meadows golf, hotel, spa reserves the right to refuse admission and operates a smart casual dress code-training shoes and ripped jeans are not permitted.
15. The hotel will endeavour to try to sit groups together wherever possible. however, we will not accept individual table plans.
16. The hotel reserves the right to fill tables with other groups.
17. An allocation of bedrooms for each party night has been set aside; the accommodation reference code for your party night will be provided on your confirmation. All rates are subject to availability. once the allocation is full our best available rate will apply.

18. No corkage available.
19. Bar accounts can be arranged prior to the date of your event - with credit card details provided - only one credit card per booking can be accepted.
20. On the events where Santa is attending, due to popular demand, there will be a queue.
21. Gift exchange and gift bags are not allowed in our function rooms. If you are attending an event and wish to exchange gifts, this will need to be done in public areas of the resort, and gifts/gift bags will be held by our security department and returned to our guests after the event. The hotel reserves the right to search individuals.
